- 2. *Khaptad Chhanna Rural Municipality* invites electronic bids from eligible bidders for the construction of *10 Bedded Hospital Building* under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs* 8,63,00,000.00
- Minimum Work experience of similar size and nature: Constructed one hospital building with value of project equal to NRs. 9,21,00,000.00
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents by visiting PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document i.e. NRs. 10,000.00 in the Project's Rajaswa (revenue) account as specified below.

Electronic bids must be submitted to the *office of Khaptad Chhanna Rural Municipal Executive*, *Chhanna*, *Bajhang* through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before *12:00 Hours* on *2078/01/07*. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hours on 2078/01/07 at the office of Khaptad Chhanna Rural Municipal Executive. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of 32,50,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
