date of publication. Bid shall be sealed in an envelope addressing to this office address indicating name of the contract,
contract identification number, bidder's name and address. Bids received after the deadline shall not be accepted.

 Bids shall be opened in the presence of Bidders' representatives, who choose to attend with original related documents at 2:00 PM on 31th day of Notice Published. Bids must be valid for a period of 90 days counting from the day of bid

opening.

5. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.

the original bid submission deadline.
